### Multi-Child Discount

This discount applies to families with three or more children attending Trinity Academy. Full tuition and fees apply to the two oldest children. Beginning with the third child, a **40% discount** on tuition will be given. The multi-child discount does not apply to the Student Activity Fee.

## **Important Dates and Deadlines:**

Friday, January 19, 2024 – Deadline to apply for First Round of Financial Assistance (FA).

Friday, February 9, 2024 – Deadline for FA applicants to apply for NC Opportunity Scholarship.

**\*\*Wednesday, February 28, 2024** – Re-enrollment deadline. Save \$500, per student, by completing re-enrollment by 4:00 pm on <u>Wednesday, February 28, 2024</u>. There is no guarantee of available enrollment space after February 28, 2024.

**February 29-March 29, 2024** – Open enrollment period. \$500 re-enrollment fee per returning student. There is no guarantee of available enrollment space as new students are offered admission.

**April 1, 2024** – Provided space is available, all returning students enrolling on or after this date must complete the full application process and submit a \$125 per child application fee as well as pay a New Family Fee (\$1,000 for 1st child, \$500 for 2nd child, \$1,500 family max).

#### Miscellaneous Fees

Returned Check or Non-sufficient funds (NSF) fees on any item: \$35.00 per incident.

## Late payments:

**TUITION** - Any past due tuition balance will incur a \$50 late fee *per student* each month until payment arrangements are made.

**INCIDENTAL BILLING (IB)** – Any unpaid IB balances after the 15<sup>th</sup> of the month will incur a \$10 late fee <u>per student</u> each month until payment arrangements are made.

**Payment Options** – Each family is required to pay a **10% deposit** of TOTAL FINANCIAL OBLIGATION either by ACH bank transfer or credit card through Veracross Online Re-Enrollment. Once your deposit is made, the <u>REMAINING</u> <u>FINANCIAL OBLIGATION</u> will be billed through your Veracross Student Billing portal. The <u>REMAINING FINANCIAL</u> <u>OBLIGATION</u> will consider any payment plan discount and any reduction of TOTAL FINANCIAL OBLIGATION based on the North Carolina Opportunity Scholarship (NCOS) Tier Award expected. *Note: the payment plan discount/fee or the expected NCOS Tier Award will <u>not</u> be applied until <u>after</u> the <u>10% deposit</u>.*

Note: NCOS awards are not guaranteed by the state. Indicating intent to apply for an award still requires each household to complete ALL required steps outlined by the state to be eligible. If the NCOS award received is different than what was initially indicated at the time of re-enrollment, the Business Office will make an adjustment to your tuition billing account. Any adjustment resulting in funds owed to a family will be applied to any <u>REMAINING FINANCIAL OBLIGATION</u> or refunded. Any adjustment resulting in a balance owed Trinity will be billed and reflected in your Veracross Tuition Billing account.

## Financial Assistance (FA): deadline for completing an application for FIRST ROUND of FA is JANUARY 19, 2024

Trinity Academy offers financial assistance to families based on demonstrated financial need. All information is confidential, and every effort is made to meet demonstrated need. First round decisions will be communicated in Veracross on or around February 20, 2024. **NOTE**: For your financial assistance application to be considered in the first round of awards, your 2023-2024 tuition payments must be current, and any prior financial assistance application must be in a "VERIFIED" status.

**NEW!** Any family applying for financial assistance from Trinity <u>must also apply</u> for the NCSEAA Opportunity Scholarship (NCOS) beginning <u>February 1</u> and <u>no later than February 9, 2024,</u> and <u>meet ALL required deadlines of the NCSEAA Opportunity Scholarship program</u>.

Families with past due tuition or Incidental Billing (IB) balances are ineligible for re-enrollment until payment arrangements are made. Habitual past due balances may lead to restriction on payment methods available to that family or may result in the decision to not offer re-enrollment.

## Family Referral Tuition Credit

Trinity Academy offers any current family up to \$1,000 for the enrollment of a new family, to be applied toward tuition. A new family will be asked how they first heard about Trinity and who invited them to an event or urged them to contact Trinity. If more than one current family has had significant influence on a new family's enrollment, the amount will be divided evenly between these families.
